1. Definitions

The term "Goals" or "Goals Australia" or "us" or "we" refers to the owner of the website who is Goals at Emerald Lakes Pty Ltd (ABN 23618583510). The term "you" refers to the user or viewer of this website.

2. General Use of Website

The contents of the pages of this website is for your general information and use only and is subject to change without notice. You have no other rights in this website or any of its encompassing materials and you may not modify, edit, copy, reproduce, create derivative works of, reverse engineer, alter, enhance or in any way exploit any of this website or its contents in any manner. You shall have no rights in relation to copyright, trademarks or other of our intellectual property rights or the intellectual property rights of third parties. You may not create a link to this website from another website or document without Goals Australia's prior written consent. This website contains material which is owned by or licensed to us. This material includes, but is not limited to, the design, layout, look, appearance and graphics. Reproduction is prohibited.

3. 5 A-Side Leagues – including fees and match cancellation policy

Registration into one of or leagues is to be done via our online registration located on the Goals Australia website. To register a team, a nominated team captain must go through the registration process – outlined through the steps on the registration page – and register the team into the league. There is a non-refundable \$160 commitment fee which is to be paid prior to the start of any league and ensures your teams place within the nominated league. This commitment fee also covers the last 2 weeks of match payments for the league. There is no registration fee for any team. The person completing the registration form is responsible for collecting any fees from other players within the team. Goals has a one team, one payment policy: there are no split payments allowed. The weekly team match fee of \$80 is to be paid as one whole payment. If paying in cash, the full \$80 amount is to be given all at once. If paying by card, the full \$80 must be paid in a single transaction. Matches will not start until both teams have paid the weekly match fee/any outstanding balance.

The full league fee for a team will be \$80 times the length of the league (number of weeks the league will be run for). The total amount will be deducted by the \$160 commitment fee once the team has been registered with the remaining amount to be paid on a weekly basis of \$80 (this being the team match fee). A team is able to pay more than the weekly team fee of \$80 if they wish to do so; we require the team to pay the minimum amount of \$80 per week, per team to take the pitch and for the match to commence. By choosing to register a team and play in one of our leagues, you are committing to paying the full amount of the league.

Goals Australia requires a minimum of 4 players to take the pitch for a team for the match to be worth full points. If there is a circumstance where a team is unable for this to happen, the match cancellation policy is outlined as such:

- a) If more than 24hrs notice has been given to the staff at Goals, the team that is unable to play will still pay their teams weekly match fee of \$80 plus half of the opponents match fee (\$40). The \$120 must be paid before the following weeks match.
- b) If less than 24hrs notice has been given to the staff at Goals, the team that is unable to play will still pay their teams weekly match fee of \$80 plus the full

- amount of the opponents match fee of \$80. The \$160 must be paid before the following weeks match.
- c) The team that is unable to field a side will forfeit the match with the result being a 10-0 win to the opponent.

Under the circumstance where a team is unable to play out the remainder of the league, the team will still be liable for the weekly match fees on a continual basis for all remaining games until a replacement team is found to take over their place within the league.

No refunds are provided for any/all league match or commitment fees.

In the event of an extreme weather occurrence, a scheduled fixture may be deemed to be unplayable and the match abandoned. The decision to abandon a match at any point due to safety reasons or the playing surface being unstable is and will be at the referee or a Goals Australia representative's discretion.

In the event of games being called off, a match that is in the first half will be rescheduled for a later date. A match that has reached at least the five (5) minute mark of the second half will result in the current score being the final result.

4. <u>Use of the Facility – including pitch hire</u>

All bookings are required to be made via either calling or emailing Goals Australia and speaking to a staff member. A valid credit card must be provided to secure any bookings. Block bookings can be made subject to availability and at a potential discount if an agreement can be made between both parties. Bookings that have been made more than 48hrs in advance will incur a 50% cancellation fee of the total booking price. Goals Australia holds the right to cancel a booking at any time; notice will be given.

5. <u>Use of Facility – including spectators</u>

Players and spectators use the Goals Australia facility at their own risk. Goals at Emerald Lakes Pty Ltd does not accept responsibility for any injury or loss from the use of our facility. Entry to Goals Australia and the use of the facility is subject but limited to:

- a) By entering you agree to be filmed, photographed and recorded. You agree that all the material we capture may be used by us for commercial purposes.
- b) No alcohol is allowed to enter the premises. Goals Australia is fully licensed.
- c) Climbing on fencing and netting structures is strictly prohibited.
- d) Smoking is prohibited within 15 metres of the club house and all pitches.
- e) Intoxicated persons will not be allowed to play.
- f) Intoxicated spectators will be asked to leave the premises.
- g) Children under 16 must be supervised at all times by an adult.
- h) Players must vacate the pitch after the end of their scheduled match.

- Any person making a booking is responsible for those who use the facility in the allocated timeslot and must inform those of the terms and conditions of use outlined on this website.
- j) Goals Australia reserves the right to remove any persons from the facility.
- k) No "commercial activities" or "outside promotion" of any kind is allowed without the consent of Goals Australia.

To do this we need EVERY player in your team to be registered with all of their correct details on file (our insurers cannot cover non-registered players). To be eligible to claim, Goals Australia must be contacted within 72 hours of the injury / incident.
